

## **AVID Emerge™ Participation**

- a. <u>AVID Emerge</u><sup>™</sup>: AVID Emerge serves a broad range of language proficiencies within an English Language Development (ELD) class at the elementary and secondary levels. This product can be utilized by educators who support multilingual scholars, instructional coaches, or multilingual learner supervisors.
