

## **AVID Summer Bridge Participation**

- a. AVID Math and Science Summer Bridge Program: AVID Math and Science Summer Bridge Program (Summer Bridge) is a set of four curriculum programs designed to increase students' math and science knowledge and skills. Math and Science Summer Bridge programs offer highengagement math and science content designed to accelerate learning by enhancing students' critical thinking, reasoning, and problem-solving skills through interactive and collaborative lessons and activities.
- b. AVID English Language Development (ELD) Summer Bridge Program: AVID's ELD Summer Bridge includes two 10-day sessions (4 hours per day) with lesson plans, presentation decks, and handouts for each day. This offering provides middle and high school English language learners with an opportunity to engage in interactive and fun lessons that focus on academic language acquisition, community building, and school connectivity.
- c. <u>AVID Summer Bridge Participation</u>: By signing the contract and paying the associated Participation fee, Client will be considered an AVID Summer Bridge "Participant" in the specific Summer Bridge programs listed on the Quote/Order or Subsequent Quote/Order. Participation runs concurrently with the Term of the Quote/Order or Subsequent Quote/Order. Participation in the Summer Bridge program requires Client to have either a New Implemented AVID Member Site or an Existing AVID Member Site in the concurrent school year.
- d. AVID College and Career Readiness Framework and Materials: Participation entitles Client to implement only the Summer Bridge program(s) listed on the Quote/Order or Subsequent Quote/Order and to use the licensed AVID Trademarks, copyrights, and other intellectual property strictly for Client's Summer Bridge implementation pursuant to the provisions of the AVID Center General Terms and Conditions and as described herein.
- e. <u>AVID Center Support</u>: AVID Center agrees to provide support to Client through AVID Center's national and/or regional offices. Participation includes support from AVID Center's national office in the following ways:
  - Access to on-demand training modules for teachers (ELD Summer Bridge also includes one live session experience);
  - Curriculum guide with all lessons and activities for teachers and online access through the on-demand training modules for all handouts and student interactive notebooks (ELD provides handouts/resources for each day in place of a curriculum guide);
  - Access to phone and email support tailored to Summer Bridge;
  - Coordination with Client to collect, report, and analyze data from participating schools; and
  - Permission/license to use the AVID Trademarks and other intellectual property as described in the AVID Center General Terms and Conditions.
- f. <u>Licensing Benefits</u>: Participation includes a license to use the AVID Trademarks to promote Client's implementation of Summer Bridge, to use and implement the AVID Methodologies, and to copy the student interactive notebooks (if applicable) from the AVID Materials for the Summer Bridge program(s) listed as implementing on the Quote/Order or Subsequent Quote/Order for educational purposes relating to AVID, all pursuant to the provisions of the AVID Center General Terms and Conditions and as described herein. Licensing runs concurrently with the Term of the Quote/Order or Subsequent Quote/Order.
- g. <u>Annual Participation/License Fee</u>: Client agrees to pay AVID Center a Participation fee according to the pricing schedule set forth on the Quote/Order or Subsequent Quote/Order.

- h. <u>AVID Methodologies</u>: Client agrees to implement Summer Bridge according to AVID guidelines and teaching methodologies (collectively "AVID Methodologies") set forth in the AVID publications, guidebooks, and materials (collectively "AVID Materials") or otherwise established by AVID Center, as the same may be modified and/or updated by AVID Center from time to time at AVID Center's discretion. Client will not materially deviate from the AVID Methodologies without the prior written consent of the Chief Executive Officer of AVID Center. Client is responsible for each of its school site's compliance with the AVID Center General Terms and Conditions and the additional terms described herein.
- i. <u>Support Person</u>: In order to build a strong district Summer Bridge program, AVID Center networks with district leaders known as AVID Summer Bridge Support Persons ("Support Person"). The primary role of the Support Person is to coordinate support for Summer Bridge within Client's school system. These individuals accept responsibility for ensuring the implementation of the Summer Bridge program components according to the AVID Methodologies and for facilitating the development of site conditions that ensure effective Summer Bridge implementation. Client agrees to maintain, at its expense, at least one (1) Support Person.
- j. <u>Teacher Training</u>: Client agrees to receive online training for the new Summer Bridge teachers and district Support Person during the planning period prior to the program implementation. The trainings are organized into asynchronous on-demand modules for teachers, one for each specific Summer Bridge program. English Language Development Summer Bridge offers one live session module in addition to one asynchronous on-demand module.
- k. <u>AVID English Language Development (ELD) Summer Bridge Program Materials</u>: Client will receive the requisite materials—daily lesson plans, presentation decks (PowerPoint and Google Slides), and digital handouts.
- I. AVID Math and Science Summer Bridge Program Curriculum Set(s): Client will purchase one (1) Curriculum Set (curriculum guide, student interactive notebook, and training module) for each new teacher of a Math or Science Summer Bridge program listed on the Quote/Order or Subsequent Quote/Order prior to each Client's initial implementation of Summer Bridge. Client has the option to purchase Curriculum Guides for returning teachers of Math or Science Summer Bridge programs previously implemented, as listed on the Quote/Order or Subsequent Quote/Order. Client shall be entitled to use AVID Math and Science Summer Bridge Curriculum Sets only for the Summer Bridge programs listed on the Quote/Order or Subsequent Quote/Order for which the materials were originally designed. Client must first seek and obtain written permission from AVID Center for additional use of the Summer Bridge Curriculum beyond its original intended purpose. Summer Bridge Curriculum Sets are not transferable. Client and its individual AVID school sites agree to ensure that each Summer Bridge classroom has adequate Summer Bridge curriculum materials. The use of the Summer Bridge Curriculum Sets, which are part of the AVID Materials, will also be subject to the provisions in the AVID Center General Terms and Conditions.
- m. <u>Student Interactive Notebooks for Math and Science Summer Bridge</u>: Students participating in Math and Science Summer Bridge will use student interactive notebooks to record and collect their individual work. Client may purchase additional interactive notebooks not provided in the Summer Bridge Program Curriculum Set from AVID Center or print and bind the notebooks from the materials available through online access to the on-demand training modules for districts implementing Summer Bridge.
- n. <u>Curriculum Shipment for Math and Science Summer Bridge</u>: AVID Center will ship curriculum upon full execution of the Quote/Order or Subsequent Quote/Order, once materials are in stock, upon Client provision of purchase order or form of payment (unless indicated otherwise on the Quote/Order or Subsequent Quote/Order). Client agrees that AVID Center makes no remedial promise and does not expressly intend to create a warranty or guarantee for any loss or damage, whether material or immaterial, arising from the late or early shipment of materials. AVID Center will send curriculum via standard ground delivery service. Any request by Client to expedite shipping will be at the expense of Client and subject to availability of the item(s) ordered.

- o. <u>Data Collection</u>: Client will provide data on student enrollment as described below:
  - Number of student enrollments in each Summer Bridge program listed on the Quote/Order or Subsequent Quote/Order; and
  - Number of schools participating in Summer Bridge.
